SSP Update

What's New?

Since our February edition we've made a number of changes, introducing new forms, courses and support products, here's a roundup:

SSP Forms

In February Site Safety Plus released updated versions to the SSP Forms. The forms now have the functionality to be completed either online or by hand and, with the exception of the Delegate Information Form (DIF), there is now one version of each form to be used for both classroom and remote delivery. Over the coming months we will be creating support materials to give our centres the confidence that they are completing each section correctly.

New version of SMSTS/SMSTS-R Course

The updated course material was released on **3rd March**, and hopefully all centres that run our Site Management Safety Training Scheme (SMSTS) Course and SMSTS Refresher Course have now had the opportunity to go through the new and updated material.

Please ensure you are preparing for any upcoming SMSTS/SMSTS-R Courses with the most up to date information, as the previous version of this course will be removed from the SSP Training Provider Portal from the 1st **April**. The new material can be found in the folder named 'NEW SMSTS and SMSTS-R Course Material' within the <u>Courses</u> section of the SSP Training Provider Portal.

SSP Development

Our Plans For 2021

Following the launch of SMSTS and the refreshed publications, we wanted to share our plans for the year ahead.

The current focus for the team is the **Directors Role in Health and Safety (DRHS)** course. We have analysed industry feedback and worked with subject matter experts to produce new course material. The course will initially be introduced as a pilot, following review by a Product Development Group, with an aim to launch fully by the middle of the year.

Once the new version of the DRHS Course has been launched, our focus for the rest of the year will be reviewing the three **Temporary Works** courses simultaneously; looking at delivery methods and considering the potential of introducing a refresher TWCTC Course.

Quality Assurance

Site Safety Plus: Course Invitations and Links

The Quality Assurance team are still getting a number of course invitations (links) via the <u>quality.assurance@citb.co.uk</u> email address for both face to face and remote courses which have not been titled correctly.

We are also receiving emails from trainers who are delivering courses who have sent the link for a course from their own email addresses. This makes the process of pairing the trainer to the course very difficult and time consuming.

We would like to remind all our Site Safety Plus Training Providers that when they provide an invitation / link for a course (for remote or classroom delivery) the email should be sent directly from themselves or from the trainer who is delivering the course on their behalf.

You should also ensure that the following information is shown in the subject line of the email, in this format:

Subject: Training Provider's Full Name/Course Notification Number/Course Title/ Date

Failure to comply with this requirement is a breach of scheme rules and could result in a sanction against your centre. See paragraphs 40-61 in the <u>Site Safety Plus Quality Assurance Requirements Document</u>.

Updated SSP Quality Assurance Requirements Document

There have been some minor updates to the **SSP Quality Assurance Requirements** document. The most up to date published version is **March 2021v1**.

Remote Delivery

A number of incidents have come to the attention of our Quality Assurance Team, where more than one individual has been showing per laptop/computer screen during courses being run remotely by our Training Providers.

As per Paragraph 41 in the SSP Quality Assurance Requirements Document;

41. The remote course must be delivered to delegates who are located at separate venues, e.g. home or work, and have an internet connection through an individual laptop or computer. Delegates that work for the same organisation can attend the course together, provided the course is accessed by individual laptops or computers. The delegates must <u>not</u> be brought together by the training organisation or intermediary into one location.

Training providers must ensure that all delegates have the correct equipment before booking a course, and are not permitted accept the attendance of delegates at a course that are appearing via the same screen.
